Eye Contact	If this product comes in contact with the eyes: <ul style="list-style-type: none">▸ Immediately hold eyelids apart and flush the eye continuously with running water.▸ Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids.▸ Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes.▸ Transport to hospital or doctor without delay.▸ Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.
Skin Contact	If skin or hair contact occurs: <ul style="list-style-type: none">▸ Flush skin and hair with running water (and soap if available).▸ Seek medical attention in event of irritation.
Inhalation	<ul style="list-style-type: none">▸ If fumes, aerosols or combustion products are inhaled remove from contaminated area.▸ Other measures are usually unnecessary.

Minor Spills	<ul style="list-style-type: none">▶ Clean up all spills immediately.▶ Avoid contact with skin and eyes.▶ Wear impervious gloves and safety glasses.▶ Use dry clean up procedures and avoid generating dust.▶ Vacuum up (consider explosion-proof machines designed to be grounded during storage and use).▶ Do NOT use air hoses for cleaning▶ Place spilled material in clean, dry, sealable, labelled container.
Major Spills	<ul style="list-style-type: none">▶ Clear area of personnel and move upwind.▶ Alert Fire Brigade and tell them location and nature of hazard.▶ Control personal contact with the substance, by using protective equipment and dust respirator.▶ Prevent spillage from entering drains, sewers or water courses.▶ Avoid generating dust.▶ Sweep, shovel up. Appropriate engineering controls	<p>Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection.</p> <p>The basic types of engineering controls are:</p> <p>Process controls which involve changing the way a job activity or process is done to reduce the risk.</p> <p>Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. Ventilation can remove or dilute an air contaminant if designed properly. The design of a ventilation system must match the particular process and chemical or contaminant in use. Employers may need to use multiple types of controls to prevent employee overexposure.</p>

Eye and face protection	<ul style="list-style-type: none"> ▸ Safety glasses with side shields ▸ Chemical goggles. ▸ Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. A written policy document, describing the wearing of lenses or restrictions on use, should be created for each workplace or task. This should include a review of lens absorption and adsorption for the class of chemicals in use and an account of injury experience. Medical and first-aid personnel should be trained in their removal and suitable equipment should be readily available. In the event of chemical exposure, begin eye irrigation immediately and remove contact lens as soon as practicable. Lens should be removed at the first signs of eye redness or irritation - lens should be removed in a clean environment only after workers have washed hands thoroughly.
Skin protection	See Hand protection below
Hands/feet protection	<p>The selection of suitable gloves does not only depend on the material, but also on further marks of quality which vary from manufacturer to manufacturer. Where the chemical is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.</p> <p>The exact break through time for substances has to be obtained from the manufacturer of the protective gloves and has to be observed when making a final choice.</p> <p>Personal hygiene is a key element of effective hand care. Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended.</p> <p>Experience indicates that the following polymers are suitable as glove materials for protection against undissolved, dry solids, where abrasive particles are not present.</p> <ul style="list-style-type: none"> ▸ polychloroprene. ▸ nitrile rubber. ▸ butyl rubber. ▸ fluorocautchouc. ▸ polyvinyl chloride. <p>Gloves should be examined for wear and/ or degradation constantly.</p>
