It is well accepted that polydimethylsiloxane fluids become permanent residents of sediment but should not exert adverse environmental effects. Physical effects such as surface entrapment have been observed when testing aquatic invertebrates in clean laboratory water, but similar effects are not expected in natural environments where a large variety of other surfaces provide opportunities for deposition. Silicone fluids are very surface active due to the hydrophobic nature of the methyl substituents. The polydimethylsiloxanes may become attached to textiles, sewage sludge, hair, algae, sediment etc. In aqueous environments, polydimethylsiloxanes are adsorbed onto sedimenting particles. Also, in the presence of nitrate ions, which exist at various concentrations in the environment, short chain siloxanes are degraded by light to the level of silicate within days.
