Numerous haloalkanes and haloalkenes have been tested for cancer-causing and mutation-causing activities. In general, the potential to cause genetic toxicity is dependent on the nature, number and position of halogen(s) and the size of the molecule. Haloalkenes are of concern because of the potential to generate genetically toxic intermediates after epoxidation. The concern for haloalkenes may be diminished if the double bond is internal or sterically hindered.

The cancer concern levels of the 14 haloalkenes and haloalkanes, have been rated, based on available screening cancer bioassays and data on genetic toxicity.
